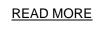
TRANSPORT COUNCIL AGREES ON FIT FOR 55 TRANSPORT FILES

COUNCIL POSITION ON DEPLOYMENT OF INTELLIGENT TRANSPORT SYSTEMS

On 2 June, the Council of the EU in in its Transport configuration agreed its position (general approach) on the revision of the Directive on the deployment of Intelligent Transport Systems, proposed by the European Commission in

December 2021. This will allow the Council presidency to start negotiations with the European Parliament (trilogues) once the latter has adopted its position.
