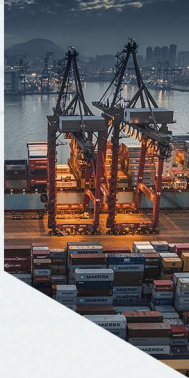


Euro-Asian Rail Corridors crossing Iran.

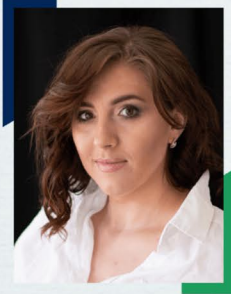

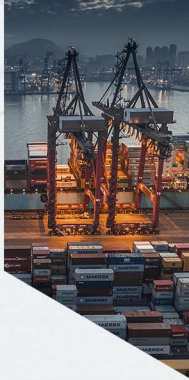
