ENVI COMMITTEE DISCUSSES ETS REVISION

On 9 September, MEPs from the Environment, Public Health and Food Safety (ENVI) Committee held an exchange of views with DG CLIMA Director Beatriz Yordi on the revision of the EU Emissions Trading Scheme (ETS). The European

Commission's Fit for 55 package proposes to extend the current EU ETS to maritime transport, gradually remove free allowances for the aviation sector and create a new separate ETS system for road transport and heating sectors.
