Warranted that their subcontractors are contracted on the same liability basis as the Assured and that that liability is insured by a reputable insurer with appropriate limits for the goods carried. That insurance must be checked by the insured. If this is not complied with then the limit is reduced to USD 100,000 for cargo liability and Deductible is increased to USD 5,000
